EMERGENCY AND FIRST AID PROCEDURES

SPECIAL FIRE FIGHTING PROCEDURES

SECTION 5 - ACCIDENTAL RELEASE MEASURES

Large spills - confine spill, soak up with approved absorbent, shovel product into approved container for disposal.
