ROUTES OF ENTRY - SIGNS AND SYMPTOMS OF EXPOSURE

EMERGENCY AND FIRST AID PROCEDURES

**INHALATION:** High concentrations are irritating to the respiratory tract; inhalation of mist may cause headache, dizziness, nausea, vomiting and malaise.

Remove affected person to fresh air; provide oxygen if breathing is difficult.

**SKIN:** Brief contact may cause slight irritation; prolonged contact may cause moderate reddening, swelling and possible necrosis.

Remove contaminated clothing; wash affected area with soap and water; launder contaminated clothing before reuse; if irritation persists, seek medical attention.

**EYES:** Contact may cause irritation and pain associated with redness and swelling of the conjunctiva.

Remove contact lenses. Flush eyes with clear running water for 15 minutes while holding eyelids open; if irritation persists, seek medical attention.

**INGESTION:** Low order of toxicity; may cause headache, dizziness, diarrhea and general weakness.

Give two glasses of water for dilution; Do not induce vomiting; never give anything by mouth to an unconscious person; seek medical attention.
