SECTION 3 - HEALTH HAZARD DATA

ROUTES OF ENTRY - SIGNS AND SYMPTOMS OF EXPOSURE

INHALATION: Exposure to vapors not likely. High concentrations may be irritating to the respiratory tract; may cause headache, dizziness, nausea, vomiting and malaise.
