ROUTES OF ENTRY - SIGNS AND SYMPTOMS OF EXPOSURE

EMERGENCY AND FIRST AID PROCEDURES

**INHALATION:** Exposure to vapors not likely. High concentrations may be irritating to the respiratory tract; may cause headache, dizziness, nausea, vomiting and malaise.

Remove affected person to fresh air; provide oxygen if breathing is difficult; if affected person is not breathing, administer CPR and seek emergency medical attention.
